Review of Service The Order of Service was reviewed. It was agreed that the Order of Service as presented would be used at the service to follow.
MOVED by J. Lackie, seconded by J. Morris, that the Order of Service be adopted.

Offering MOVED by J. Morris, seconded by S. Cameron Evans, that the offering be sent to PWS&D.
CARRIED

Housing loan from Centennial to Rev. Kim MOVED by S. Cameron Evans, seconded by J. Lackie, that the presbytery approve the housing loan terms and conditions between Centennial Presbyterian Church and Rev. Jin Woo Kim as follows:
a. The amount will be a maximum of \$100,000.
b. Before maturity the interest rate will be 0%.
c. After maturity the interest rate will be 10%.
d. Maturity will be the earlier of termination of employment or sale of the house at which time the loan will be immediately repayable.
e. The loan will be secured by a second mortgage on the house
f. There will be no repayments prior to maturity.

The Service At 7:30 PM, Presbytery joined the assembled congregation for the service of induction. D. Delpont narrated the steps and led the Call to Worship and opening prayers. Gwyn Crowe read the Scriptures. J. Lackie preached the sermon. E. Van Zoeren gave the charge to the minister and congregation.
